

### SESSION COMMITTEE PROCEDURE

STATE SESSION COMMITTEES are set up for the purpose of studying the resolutions assigned to them and to present their findings to the Delegate Body with their recommendations.

The Chairman of the Committee – the first named delegate – shall call his/her committee together at once and proceed to get their work done so they may report to the Delegate Body as early as possible, but not later than the morning of the THIRD SESSION DAY.

If there is a minority report of the committee, it shall be read before the majority report is acted on. In order to bring the minority Report before the Grange, a motion should be made to substitute the minority Report for the majority Report. If the motion prevails, the minority Report becomes the Committee Report and is then acted upon by the Delegate Body. If the motion is lost, the Majority Report will then be considered. (National Digest 2018 13.1.2)

The report of any committee may be AMENDED-ADOPTED or REJECTED by a majority vote of the Delegate Body. If the report contains simple statements of facts, it may be considered as a whole. If it contains many statements or resolutions, it may be considered section by section, or the entire report, or any part thereof may be re-committed to the reporting committee, or be referred to some other committee, with or without instructions from the Delegate Body.

When the committee report has been acted upon by the Delegate Body, the committee is discharged.

### ARTICLE II SECTION 2 CONSTITUTION

VOTING MEMBERS. The voting members shall be the Masters of Pomona and Subordinate Granges and their spouse who are Patrons, but any such Grange shall elect any member(s) as its representative(s) to the State Grange whenever the Master and/or spouse is unable to attend, and the representative(s) so elected shall be voting delegates of this State Grange, whereby each Subordinate and Pomona is entitled to two (2) voting delegates at the State Grange Convention. In the event a Pomona Master happens to also be the Master of a Subordinate Grange, that Master has the choice as to which Grange he/she wishes to represent. (2007)

### SESSION COMMITTEE INSTRUCTIONS

The delegate from the first Grange named on the committee list is Chairman of the Committee. If that Grange is not represented, the next in order automatically becomes chairman.

### **STANDARDS**

Committee standards with placards will be used to indicate where the CHAIRMAN and members of the committee may be located.

### ARTICLE I SECTION 1 BY-LAW

These By-Laws may be amended at any annual session of the State Grange by a two-thirds vote of all voting members present, provided notice of the proposed amendment has been filed with the Secretary and duly read in the Grange before the close of the first day's session.

Eight copies of all committee reports, signed by all committee members, must be submitted as follows before the committee report will be allowed on the floor: one copy to the State Master, one copy to the Overseer, one copy to each of the three Executive Committee, one copy to the Reader, one copy to the Secretary, and one copy to the Legislative Chairman. The opening banquet for the 111 Idaho State Grange hosted by Idaho State Grange officers was held at 6 p.m. and attended by 64 grangers and guests. Master Eileen Javaux recognized all 50 +year grange members and military veterans, thanking them for their service.

### **Idaho State Grange Convention**

October 18, 2019 Second Day

Worthy Master Eileen Javaux opened the first day of the Idaho State Grange in the 6<sup>th</sup> degree at 7:45 a.m.

The Grange was lowered to the 4<sup>th</sup> degree at 8:12 a.m.

The following Worthy Guests were introduced: National Lecturer Chris Hamp and her spouse Duane Hamp, WA State Master Tom Gwinn, Susie Ramm the Regional Membership Assistant for Joe Stefenoni, and GIA representative Tom McKern.

Greetings from the National Master were read by Secretary Jeannie Billmire.

Sisters Vesta Cox, Marie Nicholson and Maryellen Decker were appointed to the Election Committee and sworn in.

Election was held for District III Executive Committee. David TerBest and Don Heikkila were nominated. Results were David TerBest 23, Don Heikkila 9. David TerBest has been elected.

Resolutions COBY 04-19 AND GRAC 01-19 were withdrawn.

Worthy Sister Martha Cook read the COBY resolutions into the record.

Bonneville County Pomona Master Dorothy Ryder welcomed the body to the session. She thanked everyone who helped organize the session. She gave a door prizes to Alisha Javaux and Scott Mitson.

Brother Tom McKern, GIA addressed the body. He was reminiscing about when Jo Reed was representing GIA. They are the largest insurance agency that represent Fraternal Organizations in the U.S. He thanked Kermit Richardson for helping to create the Supporting Membership agreement. He said Chris Holbart told him earlier today that years ago two of the scholarships were issued to Mica Flats Grange members. One is a resident doctor and the other has his degree and has followed his dad into construction. Brother McKern said it was nice to hear about the results of their scholarships. He offered a special thanks to Richard Javaux and Don Heikkila for the trip to/from the airport and stated Sister Carolyn wasn't able to join him today, but she is busy in his absence.

GIA celebrated 125 years in business earlier this year. They operate in six western states. Their CEO Ryan Dudley and CFO Sean both retired. Steve Staugner is the new CEO and has been well mentored

They lost money two out of three of those years but were able to handle it because of reinsurance. Rates for auto insurance were also updated and are in the process of being reviewed.

Susie Ramm, Editor of the Oregon State Paper and Regional Assistant for Joe Stefenoni. She will be the go-to person for our region to develop membership plans for growth. Many years ago, when Grange Insurance was active in our area, we never had to worry about asking people to join but that has changed, and we need to be more aggressive about recruiting membership.

The Session was placed in recess so members could attend the Agriculture luncheon hosted by Agriculture Chairman Gordon Moir. A delicious baked potato bar was enjoyed by 55 grangers and guests. We were entertained by speakers Scott and Marie Nicholson and Mary Ann Wright was introduced and gave us a little background about herself. This is her first year on the Executive Committee.

The Session was called back to order at 1:30 p.m.

### Saturday October 19, 2019

Grange was opened in the 6<sup>th</sup> Degree at 8:45 a.m. by Worthy Master Eileen Javaux. Roll was called with 32 Delegates answering roll call.

Worthy National Lecturer Chris Hemp installed David TerBest as District III Executive Committee and Warren Eilers as Treasurer of the Idaho State Grange.

### **AGLE Committee continues reporting** – Gordon Moir Chairman

### AGLE 02-19 - Hemp in Idaho

Committee action was favorable. Body voted to accept the Committee Report and resolution was adopted.

### AGLE 03-19 - Minimum Hourly Wage for Idaho

The Committee action was favorable. Body voted to reject the Committee Report and the resolution was rejected.

# AGLE 04-19 Tax Assessment in Idaho Counties for Granges and Other Fraternal Organizations with Property

Committee action was to reject. Body voted to accept committee report and the resolution was rejected.

### AGLE 05-19 – Tax Exemption Education for State and Pomona Granges with Property

Committee voted to amend to add Community Granges to the Resolved. The body voted to adopt the Committee Report and the resolution was adopted.

#### **Resolution from the Masters' Address**

RESOLVED that the Granges of the State of Idaho strive to get the Grange more exposed to the communities around the state and strive to publicize their varied activities. Sharing the work allows others to gain ideas and implement those ideas across the State. Our members are actively involved in Service, Education, Advocacy and Agriculture.

Committee voted to agree with the Masters' Address.

Wayne moved the committee's work be accepted and the committee was thanked and released. The motion was seconded by Martha Cook and passed.

Mary Johnson gave a report from Lily Sorenson. She does not have the Community Health and Deaf Awareness Certificates ready to be distributed but assured us they will be mailed.

Community Service Director Bonnie Mitson announced the results of the Community Service contest. This is a National Contest and there must be 25% participation of the granges in a state to receive award money. In Idaho that means we must have six granges participating to qualify. **EDHE**– **01-19** Allowing for School Security

Committee amended this resolution as follows:

Now, THEREFORE BE IT RESOLVED that the Idaho State Grange should petition the Idaho Legislature to support that one or more current willing employees of each school be selected by the school's Board of Trustees to receive an extra-duty assignment and training as a school security officer and be thus employed as a school security officer, and

BE IT FURTHER RESOLVED that this school security officer is authorized to carry a concealed handgun on that school district's property while on duty as a school security officer, and

BE IT FURTHER RESOLVED, every school would be required to post, in an open and conspicuous manner, that it is protected by armed school security officers, who have active conceal and carry permits.

The Resolution was accepted as amended by the delegate body.

#### **EDHE 02-19** Honor the Work of Teachers and Districts

The committee rejected this resolution because the feeling was that the students are being taught to pass the test, not the basic material. Maureen Patterson spoke in favor of the committee's report. The resolution was rejected by the delegate body.

### **HITR 01-19** Cell Phone Use While Driving

Committee amended this resolution: RESOLVED that the Idaho State Grange urge the Idaho Legislature to create a law banning driving while using a hand-held phone in Idaho, except for situations deemed emergencies by law enforcement.

#### EDHE-01-19 ALLOWING FOR SCHOOL SECURITY

**WHEREAS**, the Edgemere Grange finds that the increased response time for police and/or other emergency persons in extreme situations due to the far-reaching distances, particularly in rural areas; and

**WHEREAS**, because it is necessary for the safety and well-being of the students and employees of the School District, to provide trained security personnel within the district to intervene, if deadly violence occurs or threatens; and

**WHEREAS**, each authorized school trained security personnel must maintain requirements necessary to be properly insured and have an active conceal and carry permit; and

**WHEREAS**, each school trained security personnel shall follow all of the District's requirements which is in partnership with local authorities, pertaining to this resolution, and is called a school security officer.

**NOW THEREFORE BE IT RESOLVED** that Edgemere Grange supports that one or more current willing employees of each School should be selected by the school's board of trustees to receive an extra-duty assignment as a school security officer and thus employed as a school security officer.

# OFFICER REPORTS MASTER'S ADDRESS

### Eileen Javaux

#### Introduction

Brothers and Sisters of the Idaho State Grange, I would like to welcome you to the 111th session of the Idaho State Grange. We are honored to have Christine Hamp, National Grange Lecturer and husband Duane Hamp present as our National Representatives. Also, I would like to welcome Washington State Master Tom Gwin, and Western Membership Representative, Suzie Ramm, Tom McKern, Grange Insurance and Scott Nicholson, Montana State Lecturer and his wife Marie.

Bonneville County Pomona thank you for your generosity in hosting the Idaho State Grange Session this year, you have put a lot of time and effort into making this a successful session.

In October of 2018, October of 2019 seemed like a long time away, and my greatest fears were that I had to write a speech and present it and learn to conduct a State Grange meeting with little knowledge of Robert's Rules of Order, in one year. Here I am with my first Master's address in hand, overseeing my first Idaho State Grange Session!

It was a process to get here. I'd like to tell you a little about what I have learned, what business has been conducted in the last year and recommend our steps for the future.

This summer, I opened a MaryJane Farm magazine and found the article, 7 Ways to prepare for firsts. I thought to myself, Wow this might help me. The seven first are:

- #1. Listen and Learn.
- #2. Rein in the Reluctance
- #3. Cast Away Criticism,
- #4 Take your Time,
- #5 Plan and Prep,
- #6 Hug your Humility,
- #7 Go for It.

I was elected your Master I had to rein in my reluctance and just go for it. Things were going well, and Don Johnson was mentoring me. When Don passed away unexpectedly. I had to rein in my reluctance again, step out of my bounds and go for it. And, fortunately, others stepped into mentor me along the way.

The year has been fast and furious, and I've been learning each day by trying to follow the 7 rules of first.

When Amanda Brozana visited in February, we discussed how to attract new members to the Grange. We need to change; we need to show what the Grange has to offer.

What do we have to offer to attract new members? Our National Grange Mission Statement says. "The Grange strengthens individuals, families and communities through grassroots action, service, education, advocacy and agriculture awareness."

### What we as a Grange have to offer new members is:

**Service**: Is the action of helping or doing work for someone; act of assistance. Our Granges have reported thousands of hours of volunteer service through the Community Service Reports.

**Education**: Some synonyms of education are: guidance, cultivation, development, improvement, and mentoring. All these words describe the work of the Grange. **Grangers are experts in many areas and they can provide mentoring in a multitude of ways.** 

**Advocacy:** Public support for or recommendation of a particular cause or policy. The National Grange has partnered with many programs and the Idaho State Grange supports local and state issues in the form of resolutions that indicate our needs and desires as a group.

**Agriculture Awareness:** I was raised on a ranch and as the wife of a farmer and the daughter of a Master Gardener long before there was a Master Gardeners Program. Ag Awareness has been part of my life. It has always warmed my heart to see the Idaho State Grange showing support of Idaho Agriculture through memberships with Food Producers of Idaho and Ag in the Classroom which continue to be a priority.

We are working closely with Idaho Preferred a program to identify and promote food and agricultural products grown, raised or processed in Idaho. Idaho Preferred also encourages all Idaho Child Nutrition programs to serve an all Idaho Menu on October 2nd of each year.

Megan Harper, a member of Pleasant Ridge Grange and employee for Idaho Agriculture Department/Idaho Preferred contacted me (knowing I will help her) and asked me to submit a menu to her Supervisor, who was choosing a school for the First Lady of Idaho, Teresa Little to visit. Notus had the honor of having Mrs. Little serve lunch and talk to students about Agriculture. Notus FFA chapter officers helped decorate the lunchroom, helped serve lunch, and visited with students while they ate. The "All Idaho" menu increased the students' awareness of foods grown locally and their interest in the school garden.

This was a joint effort by the **School Nutrition Association** who promotes the use of locally grown foods for students' meals, **Idaho Preferred**, which promotes "Grown in Idaho". A perfect example of teamwork to make the day successful. **To answer the question what does the Grange have to offer prospective members? Service, Education, Advocacy and Agriculture.** 

### **Finances and Budget**

I am a novice in understanding the processes and procedures of the Grange, but I am experienced in the finances of the Notus Child Nutrition Program, I have earned the trust of the School Board, Business Manager and the Administration, because they know I will do what is in the best interest of the Child Nutrition Program, and I can do the same for the Idaho State Grange if given time.

While I'm not an expert at finances, I do know how things should look. With my experience and the Executive Committee's guidance we make the best use of the funds we have. That requires skilled bookkeepers who are willing to work with us. In this past year we changed bookkeepers based on the recommendation to have a clearer picture of income and expenses. The new bookkeeper is currently setting up QuickBooks so that we can have online access within the next month at which point, we will be entering our own records. Ms. Sheila Stone of Christensen, Jackson, Stone, Vis and Hart will take

care of reconciling accounts and end year financial needs. Over the long term this will save money for bookkeeping services.

In June the Executive Committee gave their approval to have Office "B" refurbished. This was a decision that wasn't taken lightly, but to get the office rented we needed to update the area. We have an agreement with Cornerstone Property to find an occupant. We have interested renters', but no commitment has been made.

### **Going Forward**

In the next year we have more to do.

Across the state our members are actively involved in Service, Education, Advocacy and Agriculture. Sharing that work allows others to gain ideas and implement those ideas across the state. In northern Idaho an Eagle Scout project benefited the Grange Park, Upper Big Wood River Grange sponsors a seed bank. What is happening in your community that could benefit other communities. In this next year I'd like to see our grangers contributing articles for the newspaper and website that share ideas of what our grangers across the state are offering to our communities.

On a team, it's not the strength of individual players but it is the strength of the unit and how they all function together. Together we can share what we are offering our communities.

Idaho State Grange should continue to advocate and support local and state issues. In October of 1934, the Idaho State Grange session was held in Moscow, Idaho. That year in his Masters' address, W.W. Deal, voiced his concerns about adequate funding for Idaho schools. Today, funding for Idaho schools is still an issue, full-day kindergarten that "uniform" system starts to decline. I would like to see the Idaho State Grange support funding for full day kindergarten. Research shows that Full Day Kindergarten is beneficial to all involved and should be available free of charge. We already have school districts that have full day kindergarten free of charge. Those schools have moved funds from other areas to provide earlier education in reading and math rather than provide intervention when students are struggling in later years.

Temperance and Prohibition were a concern of the Idaho State Grange in 1934. The Grange disapproved of the consumption of alcohol and supported prohibition. Today's concerns are, overuse of opioids and vaping.

Over 130 people die each day from the misuse of opioids according to the National Institute of Drug Abuse. This is a serious crisis in our nation where almost 30 percent of people that are prescribed opioids for chronic pain are misusing these drugs. In the next year I ask that we look at ways we can help end this devastating epidemic in our communities.

Vaping or E-cigarettes are very popular with young people. Vaping is harmful for youth and young adults; the E-cigarettes contain nicotine and other chemicals that can damage health. States and cities have already started strengthening laws to control the sale of vape pods to stop the use of e-cigarettes in teens. The biggest concern is the increasing use by teens and the health issues it causes. Michigan has completely outlawed flavored e-cigarettes and New York is following the same course. The governor of New Jersey is quoted as saying "there is no safe vape." This has become a billion-dollar industry in annual sales, tougher regulations need to be in place.

Contest and Programs are an important part of our Grange work, encouraging non- Grangers to participate is free advertisement. In the next year I would like to encourage participation in Project Red, White and Blue, created by the Graces, to sew quilts blocks for Quilts of Valor. We created Project Men, to be charitable to homeless and less fortunate. Other contests you can encourage your IDAHO STATE GRANGE JOURNAL OF PROCEEDINGS

communities to participate in are: The National Grange Quilt Block Contest, State Contests for Family Activities and State Lecturers that provide many other opportunities for members of the community to show off their talents. Granges are encouraged to participate in The National Grange Public Relations Contest, The National Grange In Action Program.

At this time, I would like to thank Richard and all four of our girls; Amanda, Amber, Anna and Alissa for their help. Richard has started washing dishes, I even gave in and let him take over more of the garden care this summer. Amber and Alissa live nearby, and they have stepped in to help keep their Mother organized. When Pat Glassinger began having health issues and no longer was able to do the Grange Newspaper, Amber stepped up and took over the paper.

Also, I want to thank the Grangers that have served on the Financial Review Committee and the Building Sale Feasibility Study Committee. You all did an awesome job and as we move forward this next year your help will still be needed.

As I go into this next year, I would like to be intentional in my leadership role. Businessman, Jim Rohn said "The challenge of leadership is to be strong, but not rude; be kind, but not weak; be bold, but not bully; be thoughtful, but not lazy; be humble, but not timid; be proud, but not arrogant; have humor, but without folly."

I'd like you to bring this leadership ideal to your own communities.

Note 1: The assessed value of the property (per Ada Co.) has increased dramatically over the last 5 years - from \$128,300 to \$196,900. However, the "assessed value" appears to underestimate actual values in the neighborhood as evidenced by land and residential structure valuations/assessments on adjoining properties. This IDAHO STATE GRANGE JOURNAL OF PROCEEDINGS

is "helpful" to ISG to keep taxes lower, but probably underestimates a selling price or market value. See detailed Ada County Assessed valuation information below.

Note 2: The representative for Appraisal #1 gave the committee some important information regarding zoning. ISG is "grandfathered in" with a partly commercial parcel in a residential zone. Sale of the residential duplex and a splitting of the property would most certainly result in a rezoning to strictly <u>residential</u> also on the office building. No purchaser interested in commercial property would then have an interest in this residential building and lot. So any potential sale would have to be very carefully crafted to maintain the current commercial status of the office building for the purchaser.

#### Section 2. Breakdown and Analyses of Resolution Passed at ISG 2018 State Session.

- 2.1 "COBY 06-18 Sale of ISG Offices/Aptmts" Supporting Analyses of "Whereas" statements
  In response to the initial ISG President request for action, the Building Feasibility Study Committee is providing the
  following analyses of COBY 06-18 "Whereas" statements information, to aid the ISG Executive Board in its July
  2019 meeting deliberations pertaining to various alternatives:
- a.) continuing to hold properties for lease/rental income over time, or
- b.) liquidation of real estate assets (buildings and land) to provide immediate cash influx.
- 2.2 **WHEREAS**, the upkeep on these two sets of aging structures has cost the Idaho State Grange over \$51,000 to maintain and repair between June 2016 and the present [Oct 2018], Analysis: \$51,000 figure can be broken down as follows:

The \$51,000 figure in the "Whereas" statement includes \$3,600 expenditure for an outside review of ISG finances. \$40,000 would be a more accurate estimate and would equate to an average upkeep expenditure for the last 3-year period of \$13,333 per year. However, this latest three-year period spending/expense is not typical. The six years prior to 2016 had very low annual expenditures. It would be a better estimate of overall annual upkeep expenses if we calculate this based upon \$40,000 plus \$18,958 (per JOPs 2010 through 2015), which is equal to \$58,958 being the total spent over the last 9 years. This would give us an average annual upkeep expense of IDAHO STATE GRANGE JOURNAL OF PROCEEDINGS

\$6,550 per year. However, this is more than compensated for by lease/rental incomes. Annual rental income for each duplex should be \$9,000. Annual lease income for the office lease area could be \$16,800. Total rental/lease income would then be (= 9,000 + 9,000 + 16,800) = \$34,800. The commercial lease broker (Ron Ramza) provided an estimating factor of 30% for maintenance/upkeep for the Boise/Meridian area. This would be equal to (\$34,800 x 0.30) \$10,440 per year. In comparison, ISG has only averaged \$7,300 per year for the last 9 years. So, expenditures have been unusually low for the Boise/Meridian metropolitan area. The ISG could estimate long term net income from the rental/lease of the duplexes and office building of an amount equal to \$24,360 per year. So, the main problem expressed by this "Whereas" statement, is that the duplexes and the office /lease area should be consistently managed properly to keep the facilities full and income producing. Maintenance and repairs should not be postponed but occur more regularly. These are a real net income source for the ISG when managed properly.

- 2.3 **WHEREAS**, the legal costs to recover lost rent from renters who have not stayed current, are included in this total, "Legal fees" paid totaled was \$1171.00 in 2016
- 2.4 WHEREAS, managing these properties takes a significant percentage of the State Master's work time,

The ISG President gets paid for his/her time. Every Grange President should take a vested interest in their Grange Property, and the time spent managing the property generates operating income for ISG if this part of the job is done well.

2.5 **WHEREAS**, the location of the dual office makes it difficult to keep the second office rented,

This does not seem to be an accurate statement. The office space was rented to Chuck Stanley for travel magazines from 2013 through sometime in 2016/2017. ISG has received a proposal to lease the second office for \$1400 per month, with expectation to fill the lease.

2.6 **WHEREAS**, recent technological advances have reduced the originally perceived need to have an apartment onsite available for any elected master from another region in Idaho.

The duplex apartment is no longer maintained to provide a living space for the elected master. The rental/lease income from these properties has significant income potential for ISG. The duplex apartments and the second office should not be allowed to sit vacant.

2.7 **WHEREAS**, due to decrease in number of active granges in Idaho, and due to the increasing costs of building maintenance, the ISG budget has been unduly taxed to meet its expenses,

This conclusion is not supported by the facts. The costs of building maintenance are less than 30% of the income that can be produced from rental/lease of the duplex apartments and the office space. Properly managed, this will result in a net flow of income into the ISG budget, not an expense on it. In actuality, \$52,677 in rental income was reported in the JOPs for years 2010 through 2015, during which time, \$18,958 in repairs and maintenance were reported. This represents a net income of \$33,719 for that period of time. And in addition, this was true even though the income opportunity represented by these properties was not pursued aggressively or thoroughly.

#### Section 3. Further Analyses based upon FY2018 Income and Expenditures Report

- 3.1 Annual Financial Report of 2018 incorrectly overstated ISG expenditures by at least \$34,000. The problem here was that \$34,000 paid out to improve North Idaho Granges was reported as an "expense" item. It should have been reported as coming out of a designated fund the Bright family donation fund. \$10,000 spent on AC units and parking lot came from Pleasant Ridge funds, not the general ledger.
- 3.2 The amounts paid out to subordinate granges also show up as ISG expenses but would better be reflected as coming out of their designated fund accounts held in trust for those individual granges
- 3.3 Income amounts on all investments, cd, savings, should be reported more clearly. For Example: what were the amounts at the beginning of the year and their value at the end of the year, and should reflect the withdrawals, fees and earned interest and where they were redeposited.
- 3.4 Each account needs to be clearly readable and not commingled together.
- 3.5 Rental of the Main office area. Should be aggressively pursued. Even with the modest improvements to the existing structure.

This office has the potential of \$14,000 in the first year and perhaps \$17,000 per year thereafter. Duplex rent and income is a significant asset of ISG. The apartments under active rental agreements with paying renters. Income of \$9,000 to \$15,000 has been realized from the apartments in recent years (2010, 2011, 2012, 2013, 2017 and 2018; unknown amounts for 2014, 2015 and 2016).

- 3.7 Further Possible Considerations/Questions to improve Balance of Income and Expenses:
  - a. ISG must increase its cash flow to guarantee its long-term financial position
  - b. Get free from the investment accounts that are declining in value
  - c. Decrease the budget
  - d. Increase fundraising
  - e. Replace current paid jobs with volunteers as much as possible
  - f. Reduce spending at State Sessions; set a conservative budget and hold in Sessions in grange halls if needed, county fairgrounds, or other less expensive venues.
- 3.8 Increased Market Value of ISG properties: the market value of these buildings and land increased by \$63,100 over the same 3-year period in question, according to the Ada Co. 2019 assessment (going from \$133,800 to \$196,900; years 2016 to 2019). This figure has not been considered in any of the previous discussions of justification for continued investment in repairs and maintenance of these buildings. The increase in market value is significant and cannot be ignored and will only continue to benefit ISG as long as the property is owned.

## CONSTITUTION OF IDAHO STATE GRANGE

## Patrons of Husbandry **ARTICLE I – NAME**

Section 1. This Grange shall be known as the Idaho State Grange, Patrons of Husbandry.

Section 2. In all its acts, the Idaho State Grange shall be subject to and controlled by the Constitution, Laws and Regulations of the National Grange.

## **ARTICLE II – MEMBERSHIP**

Subordinate and Pomona is entitled to two (2) voting delegates and each Junior Grange is entitled to one (1) voting Subordinate delegate at the State Grange Session. Effective starting with 2008 session.

**Section 1. Membership** The membership of the Idaho State Grange shall consist of four classes of membership: regular, who are patrons in good standing who hold the Sixth Degree; associate; supportive; and E-Membership.

Section 2. Voting Members The voting members at the State Session shall be the Masters of Pomona and Subordinate Granges and their spouses and Junior Leaders, all of them being Patrons, but any such Grange shall elect any member(s) as its representative(s) so elected shall be voting delegates of this State Grange; whereby each the event a Pomona Master happens to also be the Master of a Subordinate Grange, that Master has the choice as to which Grange he/she wishes to represent. (2007)

Section 3. Classes of Members Membership at the State Session shall be divided into two classes: voting and honorary. The first-named class shall consist of the representatives and their wives or husbands. The second-named class shall be all other members of the State Grange as enumerated in Section 1. Honorary members shall be entitled to all rights and privileges, including the holding of office, except the right to vote.

**Section 4. Representation** No Pomona, Subordinate or Junior Grange shall be entitled to be represented at any meeting of the Grange unless all sums due this Grange there from are paid up to September 30<sup>th</sup>, next preceding the Annual Session of the State Grange.

#### ARTICLE III – OFFICERS

**Section 1**. The officers of this Grange shall be of the same number and name as provided in the National Grange Laws.

**Section 2.** The regular election of officers shall take place at the annual session held in even numbered years. This election is to begin the morning of the first day of the session after the Grange has opened and roll call taken. (2010)

**Section 3**. Vacancies shall be filled by election by the State Grange, if in session, or at the first meeting after the vacancy occurs. But until such meeting, the vacancy may be filled by appointment by the Master, subject to the approval of the Executive Committee.

**Section 4**. All officers are amendable to this Grange and to be tried by the State Grange for offenses, except Master and his wife or husband, who can be tried only in National Grange.

### **ARTICLE IV – MEETINGS**

**Section 1.** Effective with the 2006 session, this Grange shall hold its annual meeting the second full week in October of each year.

#### Section 2.

a. The host convention site to be selected three years in advance and reported at the State Grange meeting three years in advance. An adjoining district may assist by invitation of the host district. (1989)

b. All Subordinate Granges within the State shall pay a fee of \$25 to the host Pomona to help defray expenses of the annual session, balance of funds after expenses to be turned over to the Idaho State Grange. (1999)

c. The Executive Committee person from the respective district shall be the person in charge of finding the location in their district.

**Section 3.** Special meetings may be called by the Master and Secretary upon request of the Executive Committee or the written request of 35% of the qualified Subordinate Granges.

**Section 4.** When a special meeting is to be held, the Secretary shall give at least thirty days' notice of the same to the Masters and Secretaries of all Pomona and Subordinate Granges.

**Section 5.** Quorum. Delegate present at roll call from fifty-one percent of the Subordinate and Pomona Granges registered prior to the

opening of the State Session shall constitute a quorum for the transaction of business, but a lesser number may adjourn from day to day. (1992)

**Section 6.** The State Grange will assume and pay the costs incidental to State Session at the discretion of the Executive Committee. If it is necessary to expedite plans, the Executive Committee has authority to delegate the State Master and Executive Committee member from the Host District to meet with the Host Grange to finalize the plans for Annual Session. (2007) Section 7. All members attending the Annual Session of Idaho State Grange pay a registration fee of \$15.00 to be used to offset the cost of the session starting with the 2008 Session. (2007)

## ARTICLE V – DUTIES OF OFFICERS

Section 1. Master/President It shall be the duty of the Master to preside at all meetings of the Grange; to see that the officers and members of committees properly perform their respective duties; to see that the Constitution and By-laws of the National Grange, the Constitution and By-laws of the State Grange, and the Rules and Regulations of the Order are obeyed; to appoint, except where otherwise provided for, all committees that may be named by the Grange; and to perform such other duties as pertain to his office or are required by these articles and the usage of the Order.

Section 2. Overseer/Vice President It shall be the duty of the Overseer to assist the Master; to preside over the Grange in the absence of the Master, and in case the office of Master shall be vacant, he shall fill it until the next annual meeting. He shall also meet with the Executive Committee and serve as parliamentarian at the annual session at the discretion of the State Master. (2011)

Section 3. Lecturer. It shall be the duty of the Lecturer, in addition to the duties prescribed by the Manual, to have charge, subject to the approval of the Master, of the educational and literary work of the Order, to be executed through the Subordinate Lecturers of the State; also to establish such a series of correspondence and reports as will result in a thorough

knowledge of efficient lecture work being done in every Grange in the State.

**Section 4. Steward**. The Steward's duty shall be to have charge of the inner gate and perform such other duties as are prescribed by the Manual.

**Section 5. Assistant Steward**. This officer shall, in the absence of the Steward, assume his duties and perform the duties defined by the Manual.

**Section 6. Secretary**. The Secretary shall make and keep complete and accurate records of all the proceedings of the meetings of the State Grange Annual Session.

**Section 7. Gatekeeper**. It shall be the duty of this officer to carefully guard the gate of the Grange and allow none to enter unless satisfied that he is entitled to do so, unless ordered to do so by the Master.

**Section 8.** Chaplain and Lady Officers. The duties of these officers shall be as defined by the National Constitution and manual.

### ARTICLE VI – EXECUTIVE COMMITTEE

**Section 1.** The Executive Committee of this Grange shall consist of three members, one being elected from and representing each of the following districts:

District No. I: The counties of: Valley, Canyon, and Ada.

District No. II: The counties of: Lemhi, Gooding, Lincoln, Jerome, Cassia, Bonneville, Bannock, and Blaine.

District No. III: The counties of: Boundary, Bonner, Kootenai, Latah and Idaho.

To which shall be added the Master and Overseer of the State Grange as ex-officio members with full voting privileges.

Section 2. It shall be the duty of the Executive Committee to attend to the general business transactions of the State Grange; to exercise a general supervision over the affairs of the Order during the interval between meetings of the Grange; to try cases when the State Grange is not in session; and to instruct the State Grange Office in the printing, disbursement of monies, and such other duties as may be imposed upon them by the State Grange.

**Section 3.** The State Grange Executive Committee is further authorized to select and invite speakers to address the State Grange on subjects which the Committee feels are of vital Grange interest.

**Section 4.** The Executive Committee shall affect its own organization, by choosing a Chairman and Secretary. The Chairman is empowered to call meetings of the Committee as the consideration of business and Grange matters may demand and said members shall be notified by written or printed notice at least seven days before the date of meeting.

**Section 5.** The members of the Committee shall receive a per diem as fixed from time to time by the State Grange, and necessary expenses while engaged in the discharge of duties enjoined upon them which shall be paid in full for services and expenses.

**Section 6.** At each annual meeting, the Executive Committee shall make a full report of their acts during the year.

**Section 7.** The Executive Committee shall examine and report the financial status of the Idaho State Grange to the State Grange no later than the first session of the second day. (1995)

### ARTICLE VII – SUSPENSIONS

**Section 1**. Any officer of the State Grange, except the Master, who is amenable to the National Grange, who may neglect or refuse to perform the duties of his office, may be suspended from office by at least a (2019) two-thirds vote of the Executive Committee, after a fair and impartial trial by said Committee.

### ARTICLE VIII – FISCAL YEAR

**Section 1**. The fiscal year of the State Grange shall end on the thirty-first day of August of each year. (2000)

### **ARTICLE IX – AMENDMENTS**

**Section 1.** This Constitution may be amended at any annual session of the State Grange by a two-thirds vote of all of the voting members present, providing notice of the proposed amendment been filed

with the Secretary and duly read in the Grange before the close of the first day's session.

### IDAHO STATE GRANGE BY-LAWS ARTICLE I – GENERAL PROVISIONS

Section 1. Bonds. The Secretary and Treasurer of State, Pomona and Subordinate Granges shall each give bonds in such sums as provided for by the National Grange, and payable to the Executive Committee. In case of forfeiture, the amount collected on forfeited bonds shall be held in trust by the Committee until the proper officer is installed.

Section 2. Regalia. It shall be the duty of members and officers of State, Pomona, and Subordinate Granges to be clothed in proper regalia as soon as the same shall have been provided and the officers to wear their jewels and carry the emblems of their offices when open as a Grange. Only Granges opened in form and working under a charter or dispensation and members of the Order called together by the Master of the State Grange or his deputies for instruction shall be entitled to use the unwritten work of the Order.

### Section 3. Elections.

- (a) All elections in the Granges shall be by ballot, and a majority of all legal ballots cast shall be necessary for a choice.
- (b) The election of the officers of the Idaho State Grange shall start by nominations from the floor for candidates for each office. No nominating speeches shall be made, but the name and Grange of each nominee shall be given, and all candidates present shall be presented on the floor. Each ballot shall have printed on it the title of the office being voted on. Each officer shall be elected upon a separate ballot according to name and rank as provided for in the National Grange Laws.

Anyone who receives the majority of all legal votes cast on the first ballot will be declared elected. If no election is declared, the names of those two candidates having the highest number of all legal votes will be announced and a new ballot taken (2003). The election process will continue until all the officers are elected in like manner. (1998)

**Section 4. Claims.** No claims against this Grange will be allowed or paid unless the same be presented for audit or payment within six

months from the time the same was incurred (1987).

**Section 5. Books.** Each officer in every Grange shall, at the expiration of his term of office, deliver to his successor or other authorized person, when duly installed, all books, papers, moneys, implements, or other property of all description pertaining to his office or belonging to the Grange.

Section 6. Dues. Any Subordinate Grange which fails to pay its dues to the State Office for a period of two quarters, shall be considered defunct (unless said Grange has some reason, acceptable to the Executive committee, why such dues have not been paid) and all whatsoever books, papers, regalia, moneys or other property shall immediately revert to the State Grange. Possession and title thereto shall be given to any member of the Executive Committee, or other person duly authorized by them, to be held in trust by the State Grange for use of aforesaid Subordinate Grange, if such Grange shall reopen and again functions as such within a period of seven years. If said Subordinate Grange fails to reopen within the aforesaid seven years, then said property shall be used for the benefit of the Order as the State Grange may direct.

### **ARTICLE II – DEPUTIES**

Section 1. Deputies. The State Master may appoint Deputies, as needed, up to one in each District and General Deputies, as needed. Deputies are to serve a two-year term, unless appointment is sooner revoked. (a) It shall be the duty of Deputies to follow directions of the State Master and to visit Granges in their area and offer assistance when needed. (2008)

Section 2. Districts. The Master shall, in connection with the Executive Committee, divide the State into Districts. (2008)

Section 3. Compensation of Deputies. The compensation of Deputies shall be fixed by the Executive Committee of the State Grange.

### **ARTICLE III – COMMITTEES**

**Section 1. Legislative Committeeman.** A Legislative committee person shall be appointed by the Executive Committee of the Idaho state Grange. The term of the Legislative Committee IDAHO STATE GRANGE JOURNAL OF PROCEEDINGS

person shall run concurrent with that of the State Grange Master unless the appointment is sooner revoked.

### **Section 2. Session Committees.**

- (a) Session committees shall be appointed by the Master and Executive Committee on or before the tenth day of September of each year from among the Officers, Deputies, Past Masters and representatives of Pomona and Subordinate Granges and spouses of the persons above classified, whom they have reason to believe, will be present at the next session of the Grange.
- (b) To these committees shall be referred such matters as are appropriate for consideration and should any of the appointed members be absent on the first day of the annual meeting; the Master may fill the vacancies as above provided.
- (c) All resolutions must be read to the delegate body exactly as written and each change or amendment requested by the committee or delegate body be voted on separately before it becomes part of the original resolution. The resolution shall then be read and acted upon by the delegate body as amended. Session rules will supersede, if adopted on the first day of session.

Section 3. Election Committee. Election Committee members are to be Grange members in good standing, who are non-delegates from their respective Districts, however, if a nondelegate is not present, the State Grange Master may appoint a delegate in good standing from said district to fill this post. (1994)

**Section 4. Special Committees.** Special committees may be appointed from time to time as the Grange may order.

**Section 5. Number and Quorum.** Each committee shall consist of not less than three members. A majority of members shall constitute a quorum for the transaction of business.

# ARTICLE IV – COMPENSATION OF OFFICERS AND MEMBERS

The elected and appointed officers of the Idaho State Grange shall receive a salary, or per diem, or both as set by the delegate body.

A salary study committee shall be appointed and will report on the off-election year. The salary for the State Grange Treasurer was eliminated as of October 30, 1988.

The necessary office equipment and supplies and the necessary expenses incurred while in the service of the Order when away from home shall be determined by the Executive Committee of the Idaho State Grange.

Mileage to state officers, deputies, committee heads, and voting delegates is now in the Grange Policy. (1999)

### **ARTICLE V – DEGREES**

**Section 1**. **Pomona.** Any 4<sup>th</sup> Degree member in good standing may receive the degree of Pomona from the Grange at the time of its annual meeting upon payment of a fee of \$1.00.

**Section 2. Pomona Affiliation.** Inasmuch as the 5<sup>th</sup> Degree is conferred in each district or at the State Grange Session, it is provided that such 5<sup>th</sup> Degree members may, be presentation of proof of such advancement and by paying the regular fee (\$1.00), be affiliated with the Pomona within whose jurisdiction his or her Subordinate is located.

**Section 3. Flora.** Any 5<sup>th</sup> Degree member may receive the Degree of Flora during the Annual Session of this Grange upon the payment of the fee (\$5.00) fixed by the National Constitution and By-laws.

## ARTICLE VI – QUORUM AND ORDER OF BUSINESS

**Section 1. Quorum.** A quorum is made up of delegates answering roll call representing 50 percent plus one of the Subordinate and Pomona granges that are eligible to have delegates and officially registered. If a quorum is not present, Article IX Meetings, By-Laws, digest of Laws, Order of Patrons of Husbandry; paragraph 4.9.4 may be adopted in determining a quorum necessary to conduct business." The By-Laws of each state shall provide for the number of Subordinate and Pomona Granges necessary for a quorum to conduct business, provided, however, that a State Grange may determine that a delegate to such annual meeting may represent more than one Subordinate or Pomona Grange **IDAHO STATE GRANGE JOURNAL OF PROCEEDINGS** 

and such Granges will be included in the determination of a quorum". (2012)

Section 2. Order of Business. The Order of Business of each annual meeting of the State Grange shall be as outlined by the Executive Committee and Master, subject to revision by the delegate body.

**Section 3. Resolution.** In order to be presented to the State Grange Session, a resolution must be acted upon by a Subordinate or Pomona Grange in regular session, and one copy sent to the office of the State Grange at least 15 days prior to the opening day of the annual session. They must bear the signature of the Master and Secretary and the Seal of the Grange and include the address of the Grange of origin. (1966) Resolutions must be plainly typed or written in ink on a separate page. A booklet containing a copy of each resolution shall be prepared and ready for delivery to the delegates of each Grange, Officers, Committee Chairman, and special guests of the Idaho State Grange on or before the opening morning of the session. At the beginning of the second day of the session, resolution books may be distributed to any Granger who would like a copy as long as they are available. Resolutions may be presented on the floor the first day of the session by a twothirds vote of the body. (1998)

### **Section 4. Committee Recommendations**

When a committee(s) of the Idaho State Grange become aware of certain information concerning a subject that is not assigned to their specific committee and deem it necessary that the delegates need to discuss this particular subject, the committee(s) may draft a committee recommendation to be discussed by the delegates after the action has been taken on assigned resolutions.

If the delegates adopt a committee recommendation, it is to be handled the same as an adopted resolution. (1995)

### ARTICLE VII - DUES

**Section 1.** Each Subordinate grange may pay to the Idaho state Grange the full annual dues with the quarterly report on March 31<sup>st</sup> of each year for each member shown on the roll as of

December 31<sup>st</sup> of the prior year (except for 50 year members prior to January 1, 2001) with the following quarterly reports to be made in the usual manner. (2000) \*Members receiving their Gold Sheaf award after January 1, 2001 shall pay dues.

### ARTICLE VIII - STATE GRANGE OFFICE

**Section 1.** The Idaho State Grange Office shall make all necessary returns to the National Grange and keep the accounts of the Subordinate Granges with the State Grange.

**Section 2**. It shall furnish the Subordinate Granges with the necessary blanks upon which to make their quarterly reports, and other matters upon which information is required for the benefit of the Order.

Section 3. It shall also keep and publish biennially a complete roster of names, numbers and meeting dates of all Subordinate and Pomona Granges in the state, with the name and address of the Master, Lecturer, Secretary, and appointed officers of each and send a copy to the officers of the State Grange and each Pomona and Subordinate Grange secretary.

**Section 4.** It shall publish, under the direction of the Executive Committee, annually, as early as practical, a complete Journal of Proceedings of the Annual Session of the State Grange with a list of State officers and furnish one copy hereof to all officers as above. It shall report to the State Grange on the first day of each annual session the amount of dues paid by each Subordinate Grange during the year and the number of members as reported for the quarter ending September 30<sup>th</sup> of each year.

### ARTICLE IX – AMENDMENTS

**Section 1.** These By-laws may be amended at any Annual Session of the State Grange by a two-thirds vote of all voting members present, providing notice of the proposed amendment has been filed with the Secretary and duly read in the Grange before the close of the first day's session.

### ARTICLE X – ASSOCIATE MEMBERSHIP

A person with an interest in the advancement of agriculture, stewardship, and the improvement of rural life may apply for Associate Membership.

Such a member shall be entitled to receive Grange information, publications and receive the services and benefits available as determined by Idaho State Grange.

An Associate Member will not be required to appear to receive degree work and, therefore, will not be eligible to attend closed meetings of the Grange, hold office, vote or participate in Grange policy making. The associate member will be subject to all the laws, rules and regulations as provided in the Constitution and By-laws of the State and National Granges and may lose membership by suspension or expulsion.

Associate Members may be enrolled by any regular member of the Grange in which the Associate Member will be enrolled. The enrolling member will submit the name of the Associate Member to the Secretary of the Grange.

There will be two types of Associate Members:

- 1. **State Associate Members** the Idaho State Grange can enroll Associate Members from areas where there are no Granges and from the jurisdiction of Granges who do no desire to accept Associate Members. The Idaho State Grange Executive Committee, for just cause, can cancel an Associate membership by majority vote at any regular meeting.
- 2. Idaho State Grange Business Associate Members the Idaho State Grange may accept businesses that desire to support the Grange as Idaho State Grange Business Associate Members.

Annual dues shall be billed to the Associate Members at the same time regular members are billed. Refer to Grange Policy for dues.

## ARTICLE XI – SUPPORTIVE MEMBERSHIP

Each Policyholder of an accepted affiliate company of the Idaho state Grange shall be entitled to status as a Supportive Member of the National Grange and of the Idaho State Grange and shall be entitled to all membership services, privileges and benefits afforded Supportive Members as provided in the Digest of Laws of the National Grange at no cost to such policyholder.

A Policyholder, who is a fraternal or Associate Member of the Grange, may, at his or her option and compliance with the Grange's requirements, continue to maintain that status and any compliance with the grange's requirements.

### POLICY OF IDAHO STATE GRANGE

The policy statement of the Idaho State Grange may be amended at a regular Executive Board meeting.

- Memorials will be made for State Officers; present, past and members of their immediate families (child, mother or father). Amount to be left to the discretion of the Executive Board members (at least two will be contacted about amount not to exceed \$50.00).
- Bids will be called for on all maintenance work or new equipment that will be above the amount of \$150.00. At least three bids to be considered by Executive Committee Board Members. They will have the right to reject any or all bids.
- Bills will be paid only if a voucher accompanies the billing.
- Members of the office staff and Executive Board Members, as well as the State Master and Overseer shall be bonded to cover any unexpected liabilities. This to be reviewed each year. A social security number and date of birth to be furnished to office upon request.
- Changes in the Goals and Awards will be mailed to ALL Granges, as well as being published in the Idaho Grange News.
   Deadlines MUST be adhered to as well as rules on all entries.
- All contracts for any State Session must be approved and signed by at least the Master and one other Executive Board Member.
- Scholarship monies will be paid according to the stipulations set up at the time the fund is approved and may be reviewed from time to time for feasibility.
- Department Heads MUST stay within budget.
- Chaplain to send cards and/or flowers to State Officers and Past State Officers and families, with discretion along with State Master.

- Pictures of Sixth Degree and Rose Drill to be taken following the Degree work.
- Mileage to State Officers, Deputies and Committee Directors is paid at \$.45 per mile each way (2018).
- The State Master may approve any expense under \$150.00 without the Executive Committee approval.
- The Secretary's Quarterly Reports are to be sent to the Subordinate Granges from the office by the 15<sup>th</sup> of the previous month, before the end of the quarter.
- The Grange Delegates approved the following monetary items at the 2014 State Session:
- Master \$10837.50 \$903.12 per month, plus expenses
- Lecturer \$552.50; \$138.12 per quarter allotment
- Family Activities \$552.50; \$138.12 per quarter allotment.
- Secretary \$255.00 For work during State Session
- The annual dues for Associate membership in Subordinate or State Grange in Idaho shall be \$40.00. (1993)
- The annual dues for an Idaho State Grange Business Associate Member shall be \$50.00.
- Fees. The minimum fee for membership in the Pomona Grange shall be \$1.00.
- Dues. The minimum Pomona dues shall be fifty (.50) cents per annum.
- The fee of \$1.00 paid by a new member in a Pomona Grange shall apply to the fiscal year's dues
- Each Pomona Grange shall pay to the State Grange annual dues of thirty (.30) cents per member, accompanying the annual report of such Pomona Grange.
- Delegate mileage is paid at (.30) 30 cents per mile one way per Delegate couple per Grange. If only one Delegate can attend, that Delegate would still receive the 30 cents per mile one way. (2004) No mileage will be paid to Delegates for the first 50 miles traveled to the convention site. (1988) Only Delegates and State Officers driving their own vehicle, or otherwise incurring expenses to get to the

- session, will be reimbursed for their travel, beginning in 1990. (1989)
- Pianist for State Session. State Grange will pay the pianist for room and travel mileage one way for State Session. (Executive Minutes 10/6/2009).
- The annual dues for Subordinate/Community Grange members be \$28.00 (2015)

### DUTIES OF STATE GRANGE SECRETARY

Make and keep a complete and accurate record of all the proceedings of the meetings of the State Grange Annual Session.

Sign certificates as necessary after State Office Staff verifies the information and prepares certificates.

Help prepare paperwork for State Grange Session as needed and requested by Office Staff.

## DUTIES OF OFFICE STAFF OF IDAHO STATE GRANGE

Pick up mail from post office, open, date and distribute.

Update address changes as necessary.

Record and process quarterly reports as received. Make receipts for any money received.

Record dues on dues received list.

Record and acknowledge memorials as received. Handle requests for supplies ordered.

Look up information for 25 and 50-year member certificate requests.

Schedule appointments as necessary to meet with State Master or Executive Board Members.

### Weekly:

Deposit all monies received.

### Monthly:

Prepare payroll.

Payroll Federal withholding tax to bank by 15<sup>th</sup> of month.

Reconcile the bank statement.

Acknowledge Gold Sheaf members gained the previous month.

### **Quarterly:**

Compute and prepare State withholding tax, sales tax, and unemployment tax forms.

Prepare employer quarterly Federal Tax Return (Form 941).

Send quarterly allotments to State Lecturer & CWA (Jan/April/July/Sept).

Send quarterly estimated tax when required (Form 990-W) (Jan/Mar/June/Sept).

Prepare updated information for AutoSort to mail Grange News.

Prepare for Executive Committee meeting: Agenda, Minutes of previous meeting.

Mail quarterly report forms to Subordinate Secretaries with any enclosures (cipher/dues reports and other correspondence as necessary).

Mail correspondence to Pomona Secretaries as necessary.

Prepare quarterly reports to National Grange.

State Office will copy and distribute edited copies of Executive Minutes and mail to Subordinate and Pomona Secretaries.

### Annually:

Prepare annual payroll summary.

Idaho State Tax Commission transmittal (Form 956-W).

Idaho w/h Employer's Annual Reconciliation (Form 956).

Prepare and distribute employee copies of Form W-2 by January 31.

File Employer's Annual Federal Unemployment (FUTA) tax return (Form 940-EZ) for the previous year with the IRS.

Send copy of Proclamation from National Master to Governor's Office.

Schedule dinner hosting Senate and House Ag Committees and send invitation letters to them.

Arrange "Open House" at the State Grange Office in December.

State Grange Session:

Handle registrations and monies that arrive for Session.

Work with Department Heads and Committees on programs, etc.

Prepare Resolution Books for State Session.

Arrange housing for State Officers and Special Guests.

Attend State Session and handle printing as requested, late registration fees, meal tickets, etc. and deposit money as necessary. Following State Session, prepare Roster (biennial) and Journal of Proceedings with help as needed, and mail same to all Granges.

## FLAG PRESENTATION FOR IDAHO GRANGES GENERAL PROCEDURE

The flag may be presented and retired in the prescribed manner at each regular daily session of State, Pomona and Subordinate Granges, and at such other meetings or occasions as the presiding Master shall direct.

In case hall facilities or absence of regular officers will not permit presentation and retirement of the flag with due grace and respect, the ceremony should be confined to the salute, the flag being placed in its receptacle before the meeting is called to order.

The Grace occupying the center position of the Graces' station shall be the Flag Bearer. The Assistant Stewards, armed with the implements of their office, shall compose the Escort and shall guard the flag.

During the ceremony of presentation and retirement, no one shall be permitted to enter or leave the room. All members not participating in the ceremony shall stand at attention throughout the presentation and retirement, except while saluting as prescribed.

If the flag is presented, it must be done in the following manner and it must also be retired. Granges that present the flag should do so in the regular order of business without instruction from the Master.

### PRESENTATION OF THE FLAG

Immediately following the proclamation of the Overseer in the opening exercises, and before the Master calls down, the pianist sounds a chord and follows with an appropriate march. At the first note of the march, the Lady Assistant Steward takes one step forward, faces to the right, and marches until about two paces beyond the station of the Assistant Steward. faces to the left, the Assistant Steward steps directly forward into line and the Escorts without pause march abreast until they reach a line across the hall in front of the Graces' station. Facing to the left in unison, they march in file along this line until the Assistant Steward reaches a line along the hall in front of the Lecturer's station, the Flag Bearer stepping into line between the Escorts as they pass her station. Facing to the left in unison, they march abreast in close rank until they reach a line crossing the hall about three paces in front of the Assistant Steward's stations and remains there at attention. The marchers then pivot from the Lady Assistant

The marchers then pivot from the Lady Assistant Steward's position until facing abreast across the hall, march until in line with the altar, pivot again to the left, and march abreast until reaching a position which permits the Flag Bearer to take one step forward and display the flag in its proper position in front of, but not over, the altar. The Escorts assume the position of salute, inclining the staff at arm's length, its lower end beside the right foot and its upper end pointing to the union of the flag, line directed toward the Graces' station.

At the first note of the National Anthem, all members turn toward the flag, assuming the position of salute with right hand placed over the heart and join in singing the first stanza. As marching music is resumed, the Escorts step into line with the Flag Bearer; the marchers pivot to the right, march abreast until in line with the flag receptacle, pivot to the left, and proceed abreast to the line in front of the Graces' station. While the Escorts halt without turning and the music continues, the Flag Bearer continues forward, places the flag in its receptacle with the stripes pointing toward the Master's station, and steps backward into line. The marchers now face to the left in unison, and march in file until the Flag Bearer is opposite her station; they again face to the left, and the Flag Bearer steps backward to her station while the Escorts march directly to their stations, passing the altar on their respective sides.

At the first note of the presentation march, the Steward, leaving his staff at his station, carries the furled flag to the position from which he is to present it to the Flag Bearer. As the Flag Bearer

steps into line with the Escorts at her station, the Steward raises the staff to a horizontal position, upper end to his right, and unfurls the flag by rotating the staff with his left hand while supporting it with his right. He then lowers the end of the staff to present the flag to the Flag Bearer in proper position to carry. Stepping back into line with the Assistant Stewards' stations, he remains there, giving the salute at the proper time, until the Flag Bearer steps from the Escort to resume her station, whereupon he returns to his station.

### RETIREMENT OF THE FLAG

Retirement of the flag takes place without announcement immediately after the salutation in the closing exercise. The same line of marching and facings are used as in the flag presentation, the Escorts marching abreast when traversing the length of the hall and when the flag is being carried, and in file across the hall when the flag is not being carried. Following a chord to announce the retirement, a march is played; at the first note, the Lady Assistant Steward steps forward to retrace the route used in the presentation, the Flag Bearer leaves her station without escort to march to the flag, and the Steward commences his march to the position from which the flag was delivered. The Flag Bearer steps forward with the flag to a position in line with the Graces' station and waits for the Escorts. Reaching her, the Escorts pivot as she steps in front of the Lady Assistant Steward into line and they march abreast across the hall, pivot and continue abreast down the hall to the waiting Steward. Here they pause while the Steward receives the flag, face to the left and march in file across the hall, abreast to the line in front of the Graces' station, in file to the Flag Bearer's station, then all face to the left and return to their stations as in the presentation ceremony. After the Escort leaves his position, the Steward, without stepping back, raises the flag staff to a horizontal position, upper end to his right, and furls the flag by rotating the staff with his left hand, turning the upper side toward him. As the Flag Bearer leaves the Escort to step to her station, the Steward, carrying the furled flag, returns to his station.

### REMARKS

In large halls, it may be desirable for the Assistant Steward, in beginning the presentation and retirement marches, to fall into line behind the Lady Assistant Steward and march behind her farther toward the side of the room before turning towards the Masters' station.

Depending upon the size of the hall, it may be necessary for the Steward to commence unfurling the flag before the Flag Bearer joins the escort; he should complete the unfurling and be ready to present the flag by the time the escort reaches his position.

If the stations of the Master and the Graces are on a raised platform, the Flag Bearer, after placing the flag in its receptacle, does not rejoin the Escorts, but proceeds by the most appropriate route to her station. The route followed by the Bearer in placing the flag, and in joining the Escorts with the flag during its retirement, depends upon the placement of steps leading to the platform.

In carrying the furled flag, the Steward grasps the staff at the balance in his right and holds it diagonally across and in front of him, his left hand near the lower end of the staff. In carrying the unfurled flag, the Flag Bearer holds the right arm straight down by the side with the right hand grasping the lower end of the staff, the left arm across the body with the left hand supporting the staff so that the flag is carried at the side rather than in front, the staff inclined forward at an angle of forty-five degrees.



## REQUIREMENTS FOR HOSTING STATE GRANGE SESSION

The following is an outline of the program to be followed by the Pomona Grange entertaining the State Grange Annual Convention:

- Arrange for a hall, committee and display rooms and a place for the Lecturer's Open Meeting. The Executive Committee will designate the Headquarters and reserve all rooms for Officers.
- Make registration arrangements under supervision of the State Grange Office Staff.
- Arrange and secure teams for the exemplification of the Degree work in cooperation with the State Master and Executive Committee.
- Arrange for a pianist who will be in attendance at all times.
  - Be the responsibility of Host Pomona for the pianist.

Be responsible for song leader.

- Arrange for corsages and boutonnieres for the officers, spouses, and distinguished guests for the Membership Banquet and for the presentation of the Sixth Degree. The State Grange will be responsible for the Gold Sheaf and Memorial Service flowers.
- Be responsible for items in the tote bags and door prizes.
- Arrange for snacks for the hospitality room.
- Pomona to furnish enough additional Gatekeepers to man all doors during the Session and give the Executive Committee a recap of their total cost of the Session.



## CONSTITUTION OF IDAHO STATE GRANGE

### THE POMONA GRANGE ARTICLE I

### Section 1. Charters.

Charters for Pomona Granges shall be issued from the National Grange.

Applications for Charters shall be made to the Secretary of the National Grange and be signed by the person applying for the same and be accompanied by a fee of \$5.00. The number shall not be less than thirteen persons of whom there shall be not less than four of either sex. They shall all be Fourth Degree members in good standing in the district or county where the Grange is to be organized.

On such application being received setting forth (1) that the good of the Order requires the organization of a Pomona Grange in the county or district; (2) that a suitable room will be provided with the necessary paraphernalia for the convenience and work in such degree; and (3) the Master of the State Grange to provide for the organization and instruction of such Grange in accordance with Ritual of the Fifth Degree, adopted by the National Grange.

On the reception of the certificate of the officer or deputy perfecting the organization, that such Grange is organized, and charter shall be issued in due form. The deputy or other officer, before completing the organization, shall see that the room provided is in proper order and suitably arranged; that the officers are duly elected and installed, and that the membership fees are paid to the Treasurer of the new organization. It shall be his duty to instruct all officers in their several duties in the work of the degree. He shall be entitled to receive a reasonable compensation for such service.

**Section 2. Officers.** The officers of the Pomona Grange shall be the same as in the Subordinate Grange and their rank and duties shall be such as are provided for in the Manual of the Fifth Degree. Pomona Granges shall elect their officers on or after July 1<sup>st</sup> and before October 1<sup>st</sup> for a two-year term on even-numbered years beginning with 2006. (2005)

**Section 3. Membership**. Any Fourth-Degree member in good standing, on filing an

application in due form, shall, on being duly elected by majority vote, be entitled to the Degree of Pomona and membership in the Pomona Grange.

**Section 4. Meetings**. Pomona Granges shall meet once in three months and may hold intermediate meetings as may be deemed necessary for the good of the Order.

**Section 5. Fees for Membership**. The minimum fee for membership in the Pomona Grange shall be \$1.00.

**Section 6. Dues.** The minimum annual dues shall be fixed by the State Grange.

Section 7. Reports. The Secretary of the Pomona Grange shall report annually to the Office of the State Grange in a similar form and manner as from Subordinate Granges, and pay annual dues of 30 cents for each member to the State Grange, which payment shall constitute the whole of dues from the Pomona Grange to the State or National Grange.

Section 8. Pomona Membership in Good Standing. To be members in good standing in a Pomona Grange, they must be in good standing in a Subordinate Grange. Members who drop their standing in the Subordinate Grange shall automatically lose their good standing in the Subordinate Grange and shall automatically lose their good standing in the Pomona Grange, provided that reinstatement in the Subordinate Grange within a period of two years shall automatically reinstate them in the Pomona Grange without vote of the Pomona. Members must remain in good standing to vote or hold office.

It is further provided that to facilitate the work of the Pomona Secretary, lists of Subordinate members in good standing in the various Subordinate Granges belonging to each Pomona shall be furnished the Pomona Secretary by the Subordinate Secretary on forms furnished by the State Office. These lists shall be submitted at the end of each quarter.

**Section 9. Applications.** Person applying for membership in Pomona Granges shall do so in the form prescribed by the State Grange, and they shall apply to the Grange in their own district. Should they desire to join a Grange

outside their district, they shall first obtain the consent of the Grange claiming the jurisdiction.

Section 10. Pomona Grange Affiliate **Membership.** A Fifth-Degree member may not be a member of more than one Pomona Grange at the same time except that a member of a Pomona Grange may be elected to membership in one additional Pomona Grange as an Affiliate Member. A proposal for affiliate membership and election thereto shall be the same as provided in proposal for membership. Such Affiliate Members shall pay the applicable membership dues and be entitled to hold office and vote in the additional Pomona Grange, provided Affiliate Members shall be clearly designated as such in reports to the Secretary of the State Grange. Such Affiliate Members shall not hold the same office in two Pomona Granges. (1987)

Section 11. Demits. A member is entitled at any time to a demit as a matter of right, if in good standing, and clear on the books. A demit shall remain in force for six months from date of issue and shall show the date to which dues have been paid. Members having such cards may be admitted to membership in another Pomona Grange but shall be subject to the same form of petition and ballots as those first applying for membership.

**Section 12. Business.** Reports in regard called for by the State Grange must be made promptly and with as much exactness as possible and certified to by the Master or Secretary.

Section 13. Communication. All information sent to the Pomona Grange shall be communicated to the members without unnecessary delay, and through them to the Subordinate Granges in their district. All members of Pomona Granges shall be on the alert to aid the Subordinate Granges in their district and shall be prompt in communicating to them all matters affecting the interests of the Order.

To this end, they shall attend all the meetings of the Subordinate Grange with punctuality and by their example and influence, encourage the members in accordance with the design and purpose of the organization. **Section 14. Restrictions.** Sectarian and partisan questions will not be tolerated as subjects of discussion in the Pomona Grange, and no political or religious test for membership shall be applied.

**Section 15. Discipline.** The same rules of discipline as obtained in the Subordinate Grange shall apply to Pomona Granges, except that their jurisdiction shall apply only to Fifth Degree members against whom charges shall have been duly preferred in accordance with the usages of the Order.

**Section 16**. **Suspension.** When any officer (except the Master) fails or refuses to perform the duties of his/her office properly, that officer may be suspended or removed, after a fair trial by vote of the Grange.

**Section 17. Meetings.** Pomona Grange must be opened in the Fifth Degree and may later work in the Fourth Degree. Pomona Granges have authority to confer the Fifth Degree upon candidates for membership.

**Section 18**. **Annual Word.** No member of a Pomona shall receive the annual word who is not clear on the books of their Grange at the beginning of the calendar year.

**Section 19. By-laws.** Pomona Granges may make such By-laws for their own government (not to conflict with this Constitution or the Constitution of the State or National Grange) as they may deem best.

**Section 20. Amendments**. This Constitution may be amended at any regular meeting of the Grange, provided that notice in writing has been given of the intention to amend at a previous meeting. A two-thirds majority of all present must vote in favor of such proposed amendment and the vote shall be taken by ayes and nays or by a division.

### POMONA GRANGE BY-LAWS ARTICLE I – TITLE

**Section 1.** This organization shall be known as the \_\_\_\_\_ Grange No \_\_\_\_ Patrons of Husbandry.

### ARTICLE II – FEES AND DUES

Section 1. **Fees**. The minimum fee for membership in a Pomona Grange shall be \$1.00. Section 2. **Dues** The minimum dues shall be fifth (50) cents per annum.

**Section 3.** The fee of \$1.00 paid by a new member in a Pomona Grange shall apply to the fiscal year's dues.

**Section 4.** The fiscal year of the Grange shall end on December 31. Each Pomona Grange shall pay to the State Grange annual dues of thirty (30) cents per member, accompanying the annual report of such Pomona Grange.

### ARTICLE III - EXECUTIVE COMMITTEE

**Section 1.** The Executive Committee of this Grange shall consist of the Masters of the Subordinates, who are Pomona members, to which shall be added the Pomona Master and Secretary as ex-officio members.

**Section 2**. They shall attend to the general business of this Grange and have a general supervision over the affairs of the Grange during its recess. They shall instruct the Secretary regarding disbursements and attend to such other duties as may be imposed by the By-laws.

**Section 3**. At each annual meeting, the Committee shall make a full and complete report of all their transactions during the year.

### ARTICLE IV – COMMITTEES

**Section 1**. All committees shall consist of three members, to be appointed, two by the Master and one by the Overseer, unless otherwise ordered.

### ARTICLE V – AMENDMENTS

Section 1. These By-laws may be altered or amended at any regular meeting of the Grange by a two-thirds vote of the members present; provided, notice to amend shall have been given in writing at some former regular meeting.

## CONSTITUTION OF IDAHO STATE GRANGE SUBORDINATE (COMMUNITY) GRANGES ARTICLE I

Section 1 Application for Membership All applications for membership shall be made in form prescribed by National Grange and accompanied by the proper fee. When a petition is received by a Grange from a person living near the meeting place of another Grange, the Grange nearest the residence of the application shall be consulted before admitting the petitioner.

Section 2. Fees. Applicants for membership in Subordinate Grange shall pay a fee which shall not be less than \$3.00. Junior Grangers graduating into Subordinate Granges and boys and girls under 18 shall pay a fee of not less than \$1.00 (1980). The amount of fee to be specifically set by the By-laws of each Subordinate Grange. All applications shall be accompanied by such fee set and one quarter's dues in advance. Applications for Charter of a new Grange shall be signed by persons applying for same and shall pay a fee of \$1.00 according to the National Grange Digest.

### Section 3 Dues

The minimum regular annual dues in a Subordinate Grange shall be \$28.00, paid in advance, effective 1-1-08, and each Grange may otherwise regulate its own dues which must be set up in their By-laws. (2007)

All dues are payable in advance at the first meeting in January and no member of a Subordinate Grange shall receive the Annual Word who is not clear on the books of his Grange at the beginning of the calendar year. A Subordinate Grange, by a majority vote at a regular meeting, may suspend a member who is delinquent in the payment of dues for one quarter or more. Such action shall be taken upon report of the Secretary, showing the amount of the delinquency and showing that the delinquent member has been contacted at least three times before the vote to suspend.

A member, suspended for non-payment of dues, may be reinstated within one year, in the Grange from which suspended by a majority vote. Such application for reinstatement shall be accompanied by a fee of \$1.50. Such reinstatement within one year shall be deemed to restore and maintain continuous membership status.

The State Office shall see that the dues payable to the State Grange are promptly paid and in case the dues remain delinquent two quarters, the delinquent Grange shall be reported to the Master of the State Grange, who shall make another effort to collect the same in person; but if said dues are not paid at the expiration of thirty days from date of Master's notification, it shall be his duty to advise the Master of the National IDAHO STATE GRANGE JOURNAL OF PROCEEDINGS

Grange, and if, in his judgment, the facts warrant it, recommend the suspension or revocation of the said Charter of said Subordinate Grange. A Grange whose Charter has been revoked or suspended may petition the State Grange for reinstatement.

### **Section 4. Election to Membership**

When an application, as provided in Section 1, shall have been received at a regular Grange meeting, it shall be recorded. A ballot must be held on an application unless it is withdrawn. An application can be withdrawn any time before a ballot is ordered thereon, and all dues and fees paid thereon may be returned to the applicant. A Subordinate Grange is under no obligation to return the application fee to a candidate who fails to appear for initiation or conferral of the official Grange obligation.

The only way a person can legally be elected to Grange membership is by paper ballot. A ballot must be taken upon the application after all fees have been paid. It shall require 3 or more negative votes to reject an application. If less than 3 negative votes appear, the candidate will be declared elected. If a tie exists, the Master must say, "Since it is possible that a member may have cast a ballot carelessly or by mistake, the ballot will be taken again", whereupon another ballot will be immediately taken. If a tie exists again, the candidate is rejected, and the ballot cannot be reconsidered or repeated unless a member voluntarily declares that a vote was cast by mistake. Upon receiving such advice, the Master may immediately order another ballot.

After an eligible candidate has been legally elected, said candidate is entitled to initiation unless objection is made, the nature of the objection stated, and the objection sustained by a majority vote of the Subordinate Grange; or an objection thereto in writing, signed by three members of said Grange, filed with the Secretary, which objection must state that the cause thereof has arisen since the date of the applicant's election and the objection sustained by a majority vote of the Subordinate Grange. From and after the date of acceptance by ballot, all applications for membership in any Subordinate Grange shall be held pending

initiation of the candidate for a period not exceeding one year, at the end of which time said applicant shall be formally notified that unless a valid excuse for not having appeared is filed, the application will be destroyed and its approval considered null and void and the application fee will be forfeited.

The application of a candidate shall not be the subject of debate at a meeting of a Subordinate Grange. (1987)

### **Section 5 Demits**

Any member in good standing and clear on the books of the Grange is entitled to a demit upon application, therefore.

Applications for demits must be made in writing at a regular meeting of the Grange, and if the fees and dues are paid, and no charges preferred against the applicant, the Grange cannot legally refuse to grant the same.

A demitted member cannot receive the annual word, or any degree instructions, or be elected to or hold office in the Grange.

A demit disconnects a member from his Subordinate Grange, leaving him a member of the Order during the lifetime of his demit, and amenable to the Grange in the jurisdiction of which he resides. A demit shall remain in force for six months from date of issue and shall show the date to which dues have been paid. (1988) A member holding a demit may, with the consent of the Grange in the jurisdiction of which he resides, join another Grange, but must submit to all the requirements provided in the Rules and Regulations of the Order. A member holding a demit cannot be driven out of the Order by unfriendly legislation of the Grange having jurisdiction. It must either release jurisdiction or receive the member back into the Grange.

Charges may be preferred against a member of the Order holding a Demit by any member in good standing, and the Grange having jurisdiction must try the case and declare a verdict.

Application by Demit. Members who hold an unexpired demit may, upon application, accompanied by proof of previous membership and the payment of the balance of his yearly dues from his former Grange, be admitted to IDAHO STATE GRANGE JOURNAL OF PROCEEDINGS

membership in any Grange in whose jurisdiction they may reside, by a majority vote of the Grange. Such application and proof shall be referred to a committee who shall report at a subsequent meeting and a vote shall be taken by paper ballot.

### **Section 6 Membership**

A Delinquent Member is one whose dues are not paid in advance. Special significance shall be given to delinquent members who are one or more quarters in arrears; by this token, they shall be declared not in good standing and are not entitled to vote or hold office, not sit in Grange meetings, unless they have, previously to their present status, received the Annual Word. Delinquent Members, unless dropped, may become reinstated without vote of the Grange, by the payment of all back dues and current dues in advance.

A member who has been dropped from the roll for the non-payment of dues has been severed from the Grange and may be reinstated by making a regular application accompanied by the regular initiation fee and balance of the yearly dues in advance. Such application shall receive the same procedure as application for new membership, excepting that the ballot shall be a paper ballot and a majority of all voting shall elect. Provided further that this section shall not apply to past members who have been dropped after due trial for cause and convicted. An Unaffiliated Member is one holding an expired Demit, or a former paid-up member of a Grange which has surrendered its Charter, whose dues were paid up to the time of such surrender. An Unaffiliated Member may be admitted to membership upon making application, paying a fee of one dollar (\$1.00) plus balance of the yearly dues in advance. Such application shall be treated the same as the application of a new member, except that the vote shall be taken by paper ballot and a majority of all ballots cast shall elect.

Subordinate Grange Affiliate Membership. A Fourth-Degree member may not be a member of more than one Subordinate Grange at the same time except that the Fourth-Degree members may be elected to membership in one additional Subordinate Grange as an Affiliate Member. A

proposal for Affiliate membership and election thereto shall be the same as any proposal for membership except election to membership shall be by majority vote by paper ballot. Such Affiliate Member shall pay the applicable membership dues and be entitled to hold office and vote in the additional Subordinate Grange, provided that Affiliate Members are clearly designated as such in reports to State and National Grange; and further provided such Affiliated Members shall not hold the same office in two Subordinate Granges at the same time.

Subordinate Grange Associate Membership. A person with an interest in the advancement of agriculture, stewardship, and the improvement of rural life may apply for Associate Membership. Such a member shall be entitled to receive Grange information, publications and receive the services and benefits available as determined by Idaho State Grange.

Each Subordinate Grange shall make the decision if it wishes to receive Associate Members. Persons meeting the membership qualifications of Section 1 may be enrolled as Associate Members.

An Associate Member will not be required to appear to receive degree work and, therefore, will not be able to attend closed meetings of the Grange, hold office, vote or participate in Grange policy making. The Associate Member will be subject to all the laws, rules and regulations as provided in the Constitution and By-laws of the State and National Granges and may lose membership by suspension or expulsion.

Associate Members may be enrolled by any regular member or agent of the Grange in which the Associate Member will be enrolled. The enrolling member will submit the name of the Associate Member to the Secretary of the Grange.

There will be two types of Associate Members: **Subordinate Associate Members** – Associate Members who live within the jurisdiction of a Subordinate Grange which has voted to accept Associate Members.

**Subordinate Supporting Business Associate Members** – Subordinate Granges may accept businesses in their jurisdiction that desire to IDAHO STATE GRANGE JOURNAL OF PROCEEDINGS

support the Grange as Subordinate Supporting Business Associate Members. The annual dues for Associate Membership in Subordinate or State Grange in Idaho shall be \$25.00. The annual dues for a Subordinate Supporting Business Associate Member shall be \$40.00. (1993)

Each Subordinate Grange shall report the number of Associate Members who have been added or dropped from the roll during each quarter. The Secretary shall accompany each report with a remittance of \$6.00 for each Associate Member at the beginning of each quarter for which the report is made. Association Membership dues shall be collected on a quarterly prorated basis. Annual dues shall be billed to the Associate Member at the same time regular members are billed. Annual Associate Membership dues are due and payable January 1 of each calendar year. Upon failure to pay annual dues, an Associate Member is to be dropped in the same manner as a regular member.

**Section 7. Divulging Action of Grange.** No member or visitor shall divulge improperly the rejection of a candidate under penalty. It shall be the duty of the Master to read this section immediately after the rejection of a candidate, for the information of all members present.

### Section 8. Meetings.

A regular meeting is any meeting fixed by the By-laws or standing rules of the Grange. A Grange must hold at least one regular meeting each month. The By-laws must fix definitely the day and hour for all regular meetings. Special meetings may be called by the Master or by vote of the Grange for special purposes named in the call, and no other business can be legally transacted there unless so specified in the call.

**Section 9**. **Quorum.** Seven members shall constitute a quorum. No Grange can be opened in due form with less, but a lesser number may adjourn from time to time until a quorum is present.

### Section 10. Officers.

The officers of a Subordinate Grange shall be of the same number, name and rank as those provided for in the National Grange. The election of officers shall take place at a regular meeting after July 1<sup>st</sup> or after and before October 1<sup>st</sup> of even numbered years beginning in (2006). The names of officers-elect shall be reported to the State Grange at once.

The installation of officers shall take place as soon after elections as practicable, and before State Session.

**Master.** The Master shall preside at all meetings of the Grange and conduct the same according to the best of his ability, under the rules of the Order and general parliamentary law. He shall open and close the meetings in due form and decide all questions arising in the Grange, subject to appeal.

He shall also see that all reports required by the State Grange from his Grange are promptly made. At the close of his term of office, the Master shall make an annual report, recapitulating the work of the past year, and recommending measures for the year to come. **Overseer**. The Overseer shall assist the Master in his duties, and in his absence take the Master's place and duties.

Secretary. The Secretary of each Subordinate Grange shall report to the office of the State Grange promptly at the end of each quarter the number and names of all persons initiated, suspended, or expelled during the quarter, and pay to the office of the State Grange \$1.50 for each man and woman and fifty cents for each boy and girl under 18 initiated during the quarter. The Secretary shall also pay to the State Grange quarterly dues of \$6.00 for each member carried on the roll one full quarter. The report of the Secretary shall be approved by the Master of said Grange. (2007)

Each Secretary shall also promptly report to the office of the State Grange the name of the Master, Secretary and Lecturer elected at the annual election, and their post office address; also, elections to fill vacancies in those offices. The Secretary is custodian of the seal of the Grange and responsible for its use and safekeeping. It should never be used for private or individual purposes.

In case the Grange becomes dormant, he shall return the seal, charter and manuals to the office of the State Grange on demand of the Master of the State Grange.

The Secretary of the Grange shall immediately report to the Secretary of each neighboring Grange every instance of suspension or expulsion of a member who has been tried or convicted upon charges; and, in case of removal of the member, the Grange next to his new residence should be notified.

**Lecturer**. It shall be the duty of the Lecturer to lead in the literary program and the educational work of the Grange. The Lecturer shall also report twice a year to the Lecturer of the State Grange, upon blanks provided for that purposes, giving full information in regard to the character of the Lecturer's work that is being carried on in his Grange.

**Steward.** The Steward has charge of the inner gate, in which, as in all other duties, he is assisted by the Assistant Stewards, whose positions are: Assistant on the right and Lady Assistant on the left of the Overseer. The further duties of the officers of a Subordinate Grange are defined by the Manual and Constitution of the Order, the Digest of the National Grange, and the By-laws of the Subordinate Granges not in conflict therewith.

### Section 11. Appeal.

Any member of a Subordinate Grange has the right to appeal from the decision of the Master of the Grange, but if the Grange sustains the Master, no appeal to the State Grange can be taken. But, if the Grange does not sustain the Master, he (the Master) may appeal from such decision of the Grange, or if the Master refuses to obey the decision of the Grange, the Grange may by majority vote appeal from such action to the Master of the State Grange.

During the pendency of any appeal, the decision of the Master is supreme law of the Grange and is to be respected as such until the same has been overruled by the Master of the State Grange.

Section 12. Trials. All trials shall be conducted in accordance with the rules and regulations recommended by National Grange. (See Digest).

**Section 13**. **Amendments.** This Constitution may be amended at any regular meeting of the Grange, provided that notice in writing has been given of the intention to amend at a previous

meeting. A two-thirds majority of all present must vote in favor of such proposed amendment and the vote shall be taken by ayes and nays or by a division.

## SUBORDINATE GRANGE BY-LAWS ARTICLE I – NAME OF GRANGE AND TIME OF MEETING

Section 1. The name of this Grange is

Section 2. This Grange will hold regular

Section 3. Special meetings may be called by
the Grange at a meeting previous, or by the
Master. Due notice of each of such meetings
shall be given by the Secretary by postal card
addressed to the head of each family represented
in the Grange. No business shall be transacted at
such meetings unless specified in the call.
Section 4. Receiving applications or balloting
for candidates, granting demits, preferring
charges, election of officers, suspension or
expulsion of members can only be done at a
regular meeting.
Section 5. The fiscal year shall end December
31

#### ARTICLE II – ELECTIONS

Section 1. All elections, other than membership, shall be by written ballot, and it shall require a majority of all votes cast to elect.

Section 2. In any or all elections, nominations of candidates for the various elective officers may be made, providing that no nominating speeches shall be made. A motion to close nominations is never in order and members may vote for a member whether the member's name has been placed in nomination or not.

Section 3. The election of officers shall take place at a regular meeting July 1st or after and before October 1st of even numbered years beginning in 2006, and the names of officer's elect shall be reported to the office of the State Grange at once (2005). The installation of officers shall take place as soon after the election as possible.

### **ARTICLE III – DUES**

Section 1. Each member shall pay the sum (fixed by each Subordinate Grange) which is due and payable at the first meeting in January of each year.

Section 2. No member shall be entitled to vote in any meeting unless he is in good standing in his Grange.

### ARTICLE IV – STANDING COMMITTEES

Section 1. The Standing Committees of this Grange shall consist of an Executive Committee and Committees on Finance, Women's Activities and other Standing Committees listed in the Manual. The Executive Committee shall consist of three members and the Master and Secretary, who shall be ex-officio members. The Executive Committee shall be elected by ballot at the time and place of the regular annual election of officers. The other committees shall be appointed by the newly installed Master and Overseer and shall serve for two years. (2000) Section 2. The Executive Committee shall have general oversight of the business of the Grange during the interval between the meetings. Section 3. The Finance Committee shall consist of three members, and it shall be their duty to inspect and approve all bills and accounts after they have been read in open Grange and before being paid. They shall examine the books and vouchers of the Secretary and the Treasurer and report the financial condition of the Grange twice each year, at the last meeting in January and

Section 4. The Committee on Women's Activities shall have charge of the hall and have general care over all the schemes of decoration. and such other duties as shall be deemed of interest in promoting the beauty of the hall and increasing the attendance at meetings of the Grange.

Section 5. The Relief Committee shall consist of the Chaplain and two other members to be appointed by the Master and Overseer. At least one member shall be a brother. It shall be their duty to visit all members who are sick, making them as comfortable as circumstances will permit, and shall have power to call upon other members of the Grange to assist when necessary.

### ARTICLE V - BALLOTING

Section 1. Balloting for candidates for membership can only be done at a regular meeting. When the Master instructs the Steward to prepare the paper ballots, he shall announce the name of the candidate to be balloted on.

Section 2. In classes of two or over, the first ballot may be cast for the whole group. If three or more negative votes appear, each candidate

must be balloted on separately.

These By-laws may be amended at any regular meeting of the Grange, provided that notice in writing has been given of the intention to amend at a previous meeting. A two-thirds majority of all present must vote in favor of such proposed amendment and the vote shall be taken by ayes or nays or by a division.
